Panel Session 1:

Review of the Hong Kong National Security Law: implementation and the development of jurisprudence

Since the implementation of the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region ("Hong Kong National Security Law") four years ago, it has fundamentally rectified relevant key areas, and played a significant role as the statutory linchpin of the stability of the Hong Kong SAR. Highly acclaimed by the society, the Hong Kong National Security Law has laid a solid foundation for the Hong Kong SAR to progress from stability to prosperity.

As proven in practice, by adhering to the rule of law and adopting a law-based approach in formulating the Hong Kong National Security Law, the Central Authorities have fully respected the principle of "One Country, Two Systems", giving effect to the Hong Kong SAR's high degree of autonomy, and manifesting the major principle of administering the Hong Kong SAR in accordance with the law. Since the promulgation and implementation of the Hong Kong National Security Law, all judicial decisions of national security cases are made public in an open and transparent manner. This enables the society to better understand the requirements of the national security laws and how they are applied in courts.

Meanwhile, the Department of Justice and the law enforcement authorities assume a primary role in safeguarding national security by faithfully upholding the rule of law principle in discharging their duties, fully enforcing the Hong Kong National Security Law and other relevant laws in the Hong Kong SAR concerning the prevention, suppression and punishment of acts and activities endangering national security.

This session will review the practical experience, development of jurisprudence and theoretical achievements of the Hong Kong National Security Law in light of previous case laws, with a view to promoting a deeper and more accurate understanding of the relevant provisions by all sectors of the community.

Panel Session 2:

"Dual Legislation and Dual Enforcement Mechanism"

a compatible and complementary, corrective and curative approach

With high level of support from every sector of the society, the Legislative Council of the Hong Kong SAR recently passed the Safeguarding National Security Ordinance ("SNSO"), which came into effect on 23 March 2024. This marks a significant milestone in the implementation of "One Country, Two Systems", signifying the establishment of a comprehensive system in Hong Kong SAR to safeguard security and stability, and to promote good governance, which is conducive to further building a safe and stable society for everyone.

The Hong Kong National Security Law and the SNSO were respectively enacted at the State level and the Hong Kong SAR level. This session will consider how the two pieces of legislation work in tandem in a compatible, complementary manner with mutual reinforcement in their enforcement and interpretation, so as to give full play to the protection provided by the "dual legislation and dual enforcement mechanism", creating a high-level of security for Hong Kong society.

Experts and scholars will also look at how the key features of the SNSO compare with the relevant laws of the Mainland and those of other countries (common law jurisdictions in particular), and discuss how the SNSO is in line with the international standards, while at the same time gives due respect to the differences between the "Two Systems".

The Hon John LEE Ka-chiu GBM, SBS, PDSM, PMSM

Chief Executive, Hong Kong Special Administrative Region of the People's Republic of China

Mr John Lee was born in 1957. He joined the Hong Kong Police Force in 1977 as a Probationary Inspector of Police and was promoted to Deputy Commissioner of Police in 2010. He served in a variety of posts in the Force, including Assistant Commissioner (Crime), Director of Crime and Security and Deputy Commissioner (Management). He holds a Master's degree of Public Policy and Administration from Charles Sturt University in Australia.

Mr Lee was appointed Under Secretary for Security in 2012 and Secretary for Security in 2017. During his service in the Security Bureau, he was responsible for the formulation of security policies covering law and order, immigration and customs control, fire and emergency rescue services, correctional services, government flying services and other areas. He also oversaw and coordinated the work of six disciplined services departments and two auxiliary forces under the Bureau.

Mr Lee was appointed Chief Secretary for Administration in 2021. Apart from assisting the Chief Executive in policy administration, Mr Lee was also responsible for supervising the work of nine policy bureaux, harmonising the work which straddled across different bureaux and departments, as well as promoting a good relationship between the Executive Authorities and the Legislature.

Mr Lee won the Chief Executive Election of the Hong Kong Special Administrative Region on 8 May 2022, and was appointed as the sixth-term Chief Executive by the Central People's Government on 20 May 2022. Mr Lee assumed office on 1 July 2022.

Cui Jianchun, graduated with a Master's Degree of Business Administration, is currently the Commissioner of the Ministry of Foreign Affairs of the People's Republic of China in the Hong Kong Special Administrative Region. He served as the Chinese ambassador to Nigeria, the Chinese ambassador to Guyana, the Chinese ambassador to Kuwait, the Minister of the Embassy of China in France, and the Deputy Director General of the Department of Consular Affairs of the Ministry of Foreign Affairs of the People's Republic of China.

Besides, he has taken the post of the Director General of the International Cooperation and Development Department in the China National Nuclear Corporation ("CNNC"), the General Manager of the CNNC Finance Company Limited, the Deputy Director General of the Finance and Accounting Department of CNNC, the Deputy Director General of the Finance and Auditing Department of CNNC, and the Deputy Director General of the Capital Operation Department of CNNC, etc.

Mr Paul Lam has been the Secretary for Justice since 1 July 2022.

Before joining the Government, Mr Lam was a Senior Counsel in private practice specialising in general civil and commercial proceedings, and has passed the Guangdong-Hong Kong-Macao Greater Bay Area Legal Professional Examination. He was a former Vice-Chairman of the Hong Kong Bar Association from 2014 to 2017 and the Chairman from 2017 to 2018. He sat as a Deputy Judge of the High Court of Hong Kong SAR for short periods each year since 2015. He was once enlisted in the Panel of Arbitrators of the Shenzhen Court of International Arbitration and The China International Economic and Trade Arbitration Commission, and was once appointed by the China University of Political Science and Law in Beijing as professor.

Mr Lam held a number of public service positions, such as Chairman of the Consumer Council, Chairman of the Administrative Appeals Board, Chairman of ICAC Operations Review Committee and Member of Independent Police Complaints Council.

Mr Zhang Yong has been focusing on the research and practice in relation fo the "One Country, Two Systems" principle, as well the Hong Kong Basic Law and Macao Basic Law. He has also been extensively involved in the construction of the national legal system and legislative work, in particular the theoretical research and legislative practice in the area of constitutional law and constitution-related areas.

REVIEW OF THE HONG KONG NATIONAL SECURITY LAW: IMPLEMENTATION AND THE DEVELOPMENT OF JURISPRUDENCE

Ms Carmen Kan Wai-mun is a Legislative Council Member and General Counsel of Bank of China (Hong Kong) Limited. Ms Kan is one of the first batch of lawyers qualified in Hong Kong and the Mainland of the People's Republic of China. She graduated from the Faculty of Law, The University of Hong Kong (LLB, First Class Honours) and School of Public Policy & Management, Tsinghua University (Executive Master in Public Administration). For many years, she managed the Beijing representative office of the then largest international law firm as Chief Representative and Partner. She has extensive experience in managing the legal and compliance risks, as well as operational and technology risks of banking groups and is highly acclaimed in the industry. She was appointed as a member of ICAC Operations Review Committee, the Chairperson of the Working Group on Coordination and Liaison under the Steering Committee on Rule of Law Education of the Department of Justice and a member of the Hong Kong Housing Authority.

Mr William Tam joined the Legal Department (as it then was) back in 1994 and since then, has served in various advisory and advocacy sections within the Prosecutions Division. In 2012, he was promoted to the rank of Deputy Director of Public Prosecutions; and in 2015, he was appointed as Senior Counsel.

From time to time, Mr Tam was briefed to prosecute significant trials or appeals on behalf of the Hong Kong SAR. For instance, in recent years, he has prosecuted two major riot cases, including the one that took place at the LegCo Complex in 2019. He has also handled significant appeal cases, including the appeal by nine defendants who were convicted in the 2019 "Occupy Central" case, and the recent final appeal in relation to an offence of incitement to knowingly take part in an unauthorized assembly at Victoria Park in June 2021. Apart from performing court duties, Mr Tam currently heads the Commercial Crime Sub-Division with the portfolio of advising the Independent Commission Against Corruption, the Commercial Crime Bureau of the Hong Kong Police Force, the Securities and Futures Commission and other law enforcement agencie on criminal matters.

Mr Jonathan Chang practices in all areas of Chambers' work, with a particular emphasis on commercial litigation, judicial review, tax, land and regulatory work. Professor Albert Chen is the Cheng Chan Lan Yue Professor and Chair of Constitutional Law at The University of Hong Kong. He received his undergraduate and postgraduate education at The University of Hong Kong and Harvard University respectively. He began his academic career as a Lecturer in Law at The University of Hong Kong in 1984. He served as Head of the Department of Law in 1993-1996, and Dean of the Faculty of Law in 1996-2002.

He is the author of the following books: An Introduction to the Legal System of the People's Republic of China (in English); The Changing Legal Orders in Hong Kong and Mainland China (in English); The Rule of Law, Enlightenment and the Spirit of Modern Law (in Chinese); The World of Jurisprudence (in Chinese); and The World of Constitutional Law (in Chinese). He is a co-author of The Constitutional System of the Hong Kong SAR. He is also editor of the following books: Constitutionalism in Asia in the Early Twenty-First Century, and Constitutional Courts in Asia.

He previously served as a member of the Law Reform Commission of Hong Kong, the Commission on Strategic Development of the Hong Kong SAR Government, and the Hong Kong Basic Law Committee of the National People's Congress Standing Committee. He is currently a member of the National Committee of the Chinese People's Political Consultative Conference.

Professor Grenville Cross GBS, SC served as the Director of Public Prosecutions of Hong Kong from 1997 to 2009, and as the Deputy Director of Public Prosecutions from 1990 to 1997. He is a barrister-at-law, and was appointed Queen's Counsel in 1990, becoming Senior Counsel in 1997. He is Sentencing Editor of Hong Kong Cases and Archbold Hong Kong, and co-author of Sentencing in Hong Kong.
